I specifically waive any defense insofar as this contract is concerned that may arise as result of any state or local law and/or regulation or policy that may impact its enforceability.

In consideration of being allowed to participate in this water sport activity, as well as the use of any of the facilities and the use of equipment the below releases, I hereby agree as follows:

- 1. To waive and release all claims based on negligence, active or passive apart from international, want on or willful misconduct that I may have in the future against all the following named persons or entities herein referred to as lessor. The lessor is Naples Grp. I also waive and release all claims mentioned above in the same description against the property on which they do business from.
- 2. To release the lessor, their officers, employees, agents and vessels from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, executors or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether cause by active or passive negligence of the lessee harmless and indemnity than in conjunction with any injury or loss of life that may occur as a result of engaging in the above activities.

#### Safety Rules

- 1. You must be at least 18 years of age to rent our jet skis.
- 2. Jet Ski operators will not use alcohol before or during rental period.
- 3. Anyone who is pregnant cannot be Jet Ski operators and riders.
- 4. Jet Skis do not have brakes! Always operate at a safe speed. Allow yourself ample stopping space.
- 5. Know right of way rules: generally, keep to your right and safely avoid other craft. To avoid a collision, attempt to stay 300 feet away from jet skis, boats, swimmers, docks, or other obstacles until you have reached your destination.
- 6. Look in all directions constantly for other boats, skiers, divers, and swimmers. Stay alert!
- 7. Any unsafe driving practices will result in the termination of the rental. As a result of this, no refund of rental money will be made.
- 8. All jet ski and safety features are checked off with and while the customer is present.
- 9. Provide life vests, check condition of vests, and demonstrate how to use vests.
- **10.** Shown location of anchor, check condition of anchor, and demonstrate how to use anchor.
- **<u>11.</u>** Shown the designated driver how to start and operate the engine.
- **12.** Shown location of fire extinguisher and how to operate.
- 13. Shown location of vessel registration.
- 14. Shown location of vessel horn or coast guard approved whistle.
- **<u>15.</u>** Explain to customers areas that are "out of bounds". Show customers areas of interest and popular places. Explain no wake zones.
- **16.** A red flag with a white diagonal stripe down the middle represents that diving or snorkeling is in progress in the area and no vessel shall pass within 300 feet of the posted flag.
- <u>17.</u> Adhere to all no wake signs or waterway rules. Any boater who does not observe these rules is subject to fines by the U.S. Coast Guard, Marine Patrol or Sheriff's Dept.
- **18.** All riders must always wear a U.S. Coast Guard certified life jacket! No exceptions under any circumstances, **NONE**!
- **19.** It is your responsibility to make sure you bring the jet ski back in the same condition you rented it in. Deposit will be forfeited for damages and missing items (anchor, life vest etc.)
- **<u>20.</u>** Jet ski capacity for passengers will not exceed posted limits.
